MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is entered on this 18th December, 2018 between CKS Solutions, 3rd Floor, 379 A, K.P.Road, Nagercoil 629001, Kanniyakumari District, hereinafter called the party of the first part represented by Mr. C.K.Siwa , Managing Director.

AND

Stella Mary's College of Engineering, Aruthenganvilai, Azhikal post, Kanyakumari District - 629202, hereinafter called the party of the second part represented by Dr.R.Suresh Premil Kumar, Principal, Stella Mary's College of Engineering hereinafter called the party of the second part.

Three months of free training will be provided at the site of CKS Solutions for the outgoing students of Stella Mary's College of Engineering on the latest technologies available in Web Development. The students should obtain a bonafide certificate from the college for availing this offer.

2.2. Sponsored Projects

Apart from providing training to the students, CKS Solutions shall sponsor projects to the Department of Computer Science, Stella Mary's College of Engineering based on the research requirements of CKS Solutions. The cost will be decided at the time of project being sponsored by both the parties.

2.3. Projects

2.4. Research

6. Termination


