3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The programs have been granted accreditation for further 3 years. **Stella Mary's College of Engineering, Aruthenganvilai, Kallukatti Junction, Azhikal Post, Kanyakumari District-629202, Tamil Nadu** should submit fresh online application through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Stella Mary's College of Engineering, Aruthenganvilai, Kallukatti Junction, Azhikal Post, Kanyakumari District-629202, Tamil Nadu** as a whole.
